

Terms and Conditions of Elastoplast Weekly E-shop Giveaway
(Terms and Conditions)

1. Information on how to enter the Elastoplast Weekly E-shop Giveaway and prizes form part of these Terms and Conditions. To the extent of any inconsistency between these Terms and Conditions and any other published materials, these Terms and Conditions will prevail. By participating in this Promotion you accept these Terms and Conditions. Entries not made in accordance with these Terms and Conditions will be disqualified.
2. The promoter is Beiersdorf Health Care Australia Pty Ltd (**Beiersdorf**) of 4 Khartoum Road, North Ryde NSW 2113, ABN 96 620 983 020, telephone (02) 9888 0977.
3. This Promotion is open to Australian residents only who have spent \$299 RRP or more on the Elastoplast E-shop.

You must have an active ABN in order to be eligible for the Promotion.
