

# NIVEA Luminous630 Anti Stretch Marks Body Range R30 Off Coupon Promotional Offer TERMS AND CONDITIONS

- 1 These are the promotional offer specific terms and conditions for the “NIVEA ® *Luminous 630 Ant-Stretch Marks Body Range R30 Off Coupon Promotional Offer*” (“the Promotional Offer”).
- 2 The promoter of the Promotional Offer is Beiersdorf Consumer Products (Pty) Ltd, with registration number 2000/010257/07, a private company duly incorporated under the company laws of the Republic of South Africa and having its registered place of business situated at 4<sup>th</sup> Floor, Beacon Rock, 21 Lighthouse Road, Umhlanga Rocks, 4319 (“the Promoter”).
- 3 The Promotional Offer is open to only South African citizens and permanent residents of the Republic of South Africa at participating Dis-Chem Pharmacies Limited (“Dis-Chem”) stores.
- 4 The Promotional Offer is open from 09h00 on 19 August 2024 and ends at 17h00 on 31 October 2024 (the Closing Date). Any redemptions of the coupon after the Closing Date shall not qualify for the Promotional Offer.
